## **New United Supermarkets at 34<sup>th</sup> and Soney to Bring 250 New Jobs to Amarillo**

*Mass hire initiative kicks off Jan. 27 at Redeemer Christian Church*

**(AMARILLO, Texas)** – [United Supermarkets LLC](#) (United), announced today it will host a job fair beginning Jan. 27 to select staff for its new [United Supermarkets](#) store in Amarillo at 34<sup>th</sup> and Soney. Slated to open in March, the store will bring as many as 250 new jobs to the Amarillo community.

The Soney store will anchor a 19-acre site that will also include a freestanding United Express convenience store, which is scheduled to open in late January, as well as additional retail development. At 55,000 square feet, the store will be the flagship of the next generation of United Supermarkets locations, according to Monica Schierbaum, senior director of marketing for United Supermarkets, LLC. It will be the eighth company location in Amarillo and the first new United location since the Canyon store opened in 2003.

To fill the new positions, the company will host a job fair Jan. 27 through Feb. 7 in the gymnasium of Redeemer Christian Church, located at 3701 S. Soney Road in Amarillo. Times for the job fair are as follows:

- Jan. 27                                    1 – 6 p.m.
- Jan. 28 – 30                                9 a.m. – 6 p.m.
- Jan. 31 – Feb. 1                            9 a.m. – 4 p.m.
- Feb. 3 – 6                                    9 a.m. – 6 p.m.
- Feb. 7                                         9 a.m. – 4 p.m.

“We will conduct the complete hiring process at the job fair – from interviews to extending job offers and completing paperwork,” said Kami Golightly, regional talent manager for United.

During the second week of the job fair, the onboarding process will begin. Hiring selections and offers will be made, including drug testing and background checks, and training will ensue. Positions will be available across the store, including department clerks, bakers, cooks, stockers, meat cutters, checkers and sackers, according to Golightly.

Each person who applies for a position will receive a confirmation email with details about the fair. Online applicants also will receive a phone call to schedule an interview time. Since online applications are already being accepted, scheduling calls will begin immediately.
